# New Surcharge "EU ETS Surcharge (ETS)"

Dear Valued Customer,

Thank you for your continued support and choosing Ocean Network Express (ONE) to cater to your needs.

Starting from January 1st, 2024, maritime transportation industry will be included in the scope of European Union Emission Trading System (hereinafter referred to as "EU ETS").

In order to prepare for this revised regulation, ONE has decided to implement a new surcharge "EU ETS Surcharge (ETS)" with effect from January 1st, 2024 which will be valid until further notice. The tariff and calculation logic will be reviewed and updated every quarter.

This surcharge shall apply to all existing contracts and all new contracts which commence on and after January 1st, 2024. We greatly appreciate your kind understanding and cooperation on this implementation.
