Following the implementation of the **Europe Environment Surcharge (EES)** on January 1, 2025, we are providing an update on the **quarterly tariff adjustment**. The EES was introduced to align with new and evolving environmental regulatory standards. For further details, please refer to here.

We are pleased to share the **applicable EES tariff for the period from July 1, 2025 to September 30, 2025**. As part of our ongoing commitment to regulatory compliance and transparency, EES tariffs are reviewed quarterly, subject to change with prior notice.
